FastLane is a unique service designed to ease access to our Euro MTF market. Tailored to corporate issuers, FastLane offers a streamlined admission process, making it easier to connect with European investors.

### Euro MTF The listing solution for international issuers

Accounting for 36% of all the securities listed on the Luxembourg Stock Exchange (LuxSE), Euro MTF is the largest Multilateral Trading Facility (MTF) of its kind in Europe. As a wholly recognised market, Euro MTF appeals to a broad spectrum of international issuers, including a wide range of leading corporate entities. Entirely regulated by LuxSE, Euro MTF provides issuers with a flexible, cost-effective solution that caters to varying needs, while offering limited admission and reporting requirements.

### FastLane Seamless admission process for corporate issuers

FastLane streamlines the admission process of debt securities on Euro MTF by granting an exemption from the formal prospectus approval by LuxSE to public companies evolving in highly regulated markets. LuxSE conducts a limited review of information, such as terms and conditions and other publicly available information about the issuer, ensuring increased speed, efficiency and simplicity in the go-to-market process. FastLane only applies to corporate stand-alone bonds and convertibles.
